While being a criminal defense attorney can often be a thankless job, having the young man and his family embrace me and my cocounsel with enduring gratitude was priceless and a moment I will forever cherish.

How did your military service and experiences affect your life?

Serving in the Unites States Air Force JAG Corps helped me to become a better leader, father, husband, and lawyer. The Air Force has three core values: Integrity First, Service Before Self, and Excellence In All We Do. I continue to use these core values everyday to help me overcome the obstacles I face and to continue to grow as a person. The most rewarding thing about being in the military was being a part of a diverse group of people who come together for one common purpose. My time in the military provided me so many experiences and opportunities to grow that I will forever be grateful for my time serving in uniform for our country.
