From 1991 to 1995, Mark served in the administration of Kentucky Governor Brereton C. Jones as General Counsel to the Governor, Budget Director and Secretary of the Governor's Executive Cabinet. In this last position, Mark was the highest ranking official in state government below the Governor, overseeing the state's 34,000 employees and its \$10 billion biennial budget.

Mark is admitted to every court in Kentucky, the U.S. Court of Appeals for the Sixth Circuit and the U.S. Supreme Court. He has served as a Special Justice on the Kentucky Supreme Court.

Mark has been active in a number of civic endeavors. He currently serves as Chairperson of the Board of the Alliance for Catholic Urban





Education, Secretary for the Serra Club for Vocations in Northern Kentucky, and Past Chair of the Kentucky Workforce Center.

In the past, Mark has served as: a member of the Board of Directors of The Dan Beard Council, Boy Scouts of America, a member of the Board of Directors of the Kentucky Chamber of Commerce, a member of the Advisory Board of the Greater Cincinnati/Northern Kentucky International Airport, a member of the Northern Kentucky University Foundation Board of Trustees, a member of the Kentucky Council on Post-Secondary Education, Chairperson of the Board of Directors of Catholic Charities in the Diocese of Covington, and a Member of the Board of EdChoice, a statewide school choice initiative.
